### **Teaching and Advising (New School, Oxford, and elsewhere)**

I have taught a wide range of undergraduate seminars and lectures, as well as graduate seminars and lectures on topics on moral, social, and political philosophy, on aesthetics, and on figures and topics in the tradition of Oxford ordinary language philosophy. I have regularly offered independent studies, on the same wide range of topics.

I have advised numerous BA Philosophy students, and I have directed many Philosophy MAs, placing more than 35 of these students in competitive PhD programs (mostly in philosophy departments, occasionally in other fields). My advising also includes secondary roles on the committees of many PhD and MA students.

I have directed 25 PhD dissertations at the New School and served as a committee member on 30 further dissertations. I am currently directing 10 dissertations and sitting on 5 further PhD committees. To support my research students, I have since 2012 coordinated a works-in-progress series, and I have since 2009 been the faculty advisory for the New York Wittgenstein Workshop, which gives graduate students a venue for presenting their work on analytic philosophy and meeting others in the field.

I have hosted and supported numerous Fulbright, DAAD, Humboldt and other visiting scholars.

I have been an external committee member on 12 PhD dissertations outside the New School, mostly at institutions outside the US. I did Oxford-based BPhil and MPhil supervisions during the academic year 2018-2019.

### **University service (New School)**

I have generally carried a large service at the New School. While an undergraduate student (Harvard), I was board member at *Education For Action* (E4A) in Radcliffe Yard, a clearing house for and supporter of radical student activism on the Harvard-Radcliffe campus, 1987-1988 and 1989-1990. For the fall of 1988, I was myself a recipient of small grant from E4A as well as of support from the Sister City Organization of Oaxaca, Mexico and Palo Alto, CA to travel to Southern Mexico and Guatemala to study liberation theology-inspired base communities.
